#### 1.. COURSE DESCRIPTION:

A study of visual expression as presented through different media. Lecture, slides, and studio activities will introduce the student to the problems and materials of the artists.

Each week will cover a new chapter of the book, each chapter will include a reading assignment, assigned activity to check reading comprehension, Powerpoint presentation, discussion, and studio activity when appropriate to the chapter being covered.

#### 6. VISUAL AND PERFORMING ART ACTIVITY ATTENDANCE:

Over the course of the semester, the student is required to attend two (2) GCSC art events such as art show openings, artist lectures and artist demonstrations. I strongly suggest you plan ahead to be sure that you are able to attend these. To verify attendance the student is to sign in to the event. If your name is not on the sign in sheet, you will not receive credit. Sign in sheets are only available during opening receptions. All eligible events are on the calendar.

A written critique of the event you attended is required at the first class after attendance. I will make you aware of local art happenings, events, performances and shows when applicable.

#### 7. POWERPOINT PRESENTATIONS:

Presentations are viewable on the class website after each are presented in class. Any supplementary information discussed during the presentations is the responsibility of the student to take down in the form of notes. Any information given during the presentations or information from the text readings may show up on tests.

Any chapter assignments given will be due before the powerpoint presentations. Use your time wisely. Any work that turned in after the presentations will receive half credit

## 8. **STUDIO ACTIVITIES:**

This course will incorporate some studio art experiences. Reading and talking about art is beneficial, but creating art and experiencing what the artist experiences in creating will give a broader understanding of the artistic process. All materials needed to do these activities will be provided. These activities are about the process, not the final product. While a successful final product is desired, a failed piece will not adversely affect your grade if time and effort have been put into the work.

### 9. ATTENDANCE POLICY FOR THE CLASS:

Regular class attendance and participation are significant factors that help to promote success in college. Students are expected to attend all class meetings of all courses for which they are registered.

Any student who is rude and disrupts the learning process of his or her fellow students will be dealt with appropriately by the Mosley administration.
